- The Indigenous Liaison Officer for Medicare will be assisting people with applications and enrolments to obtain a Medicare Card.

Acceptable identification (ID) that can be used for proof of identity (POI) for parents and children are as follows;

- Drivers Licence
- Passport

- Certificate of Aboriginality (or letter from Land Council, Aboriginal Corp with common seal)
- Utilities Bill
- Letter from Government Agency
- Taxation Group Certificate
- Taxation Advice Notice
- Educational Certificate
- Bank Statement
- Bank Keycard
- Licensed Club Membership Card (RSL, Leagues Club etc.)
- Centrelink Statement
- MIN Card (Prisoner Identification)
- Social Security Benefits (Concession) Card
- Social Security Health Care Card
- Medicare Card
- Certificate of Australian Citizenship
- Immigration Papers (e.g. Permanent Residency Certificate)
- Travel Document (for Refugees)
- Employee or Student Identity Card
- Firearms Licence
- Boating Licence

FOR CHILDREN:

- Medicare Card
- Health Insurance Commission (HIC) Immunisation Certificate (printed not written)
- School Report
- School Identification Card
- Letter from Preschool
- Letter from Day-Care Centre
- Certificate of Aboriginality (or letter from Land Council, Aboriginal Corp with common seal)
- Medical Certificate from Doctor showing full name and DOB of child
- Bank Statement
- Centrelink letter (if the child's first name and surname appears)
